



Competition Terms and Conditions:

- This competition is promoted by HarperCollins Publishers Limited ("HarperCollins"), 1 London Bridge Street, London, SE1 9GF.
- 2. This promotion is open to all schools globally except for employees of HarperCollins (or their parent, subsidiaries or any affiliated companies) and their immediate families, who are not allowed to enter the competition.
- 3. You must be over 18 to submit the entries for this competition.
- 4. How to enter: register your interest on the competition webpage www.collins.co.uk/bigcatwritingcomp before sending your digital files to collins.international@harpercollins.co.uk. You must register online before sending in your digital submission. Hand-written paper applications will not be accepted.
- 5. All entries must be original works.
- The opening date for registration is Friday 7 June 2019 and opening date for entry submissions is Monday 9 September 2019. The closing date for entries is midnight Friday 20 December 2019. No entries received after this date will be accepted.
- 7. No purchase necessary.
- 8. Only three entries per age category allowed per school (Category 1: Ages 5-7, Category 2: Ages 8-11). In the event of more than 3 entries being submitted for each category, only the first three entries will be accepted.
- 9. The competition is open to schools across eight different regions including Africa, Americas, Asia, Australasia, Caribbean, Europe, Middle East, UK and Ireland.
- 10. There will be two regional finalists in every region (one per age category) and these regional finalists will win a regional prize each. Then the regional finalists will be shortlisted to go up against each other for the grand final overall prize (of which there will be 1 grand final winner per age category). 18 prize winners in total.
- 11. The prize for each regional finalist is to have the winning stories published on the Collins website, a Collins Big Cat goodie bag (including 10 Collins Big Cat readers and other eco-friendly goodies), £200 worth of Collins books of your choice, and an engraved shield.
- 12. The grand final winner will also win a trophy for their school, as well as have their story transformed into a video and read out by a Collins Big Cat author, posted on the Collins website and on our social media channels.
